## Fees Assessed for Meeting at CKA

Melissa Hart, Mollie Marks, Nicki Cohen

Questioned why some groups are charged fees for extra-curricular activities using the building and others are not. They asked that the Board apply fees in a fair and consistent way across the board. Bob Lennard explained that for groups which are not open to new members there is a fee assessed to meet at CKA. Bob explained reasoning: Since Musar Group is closed (not open/offered to all congregants - nobody else can join) it's not a typical group meeting in that way. Also, Musar is not on the CKA Calendar. This is the reason why the Musar group is being charged a fee for using the building. The guests asked if all groups use the utilities, why aren't fees across the board? The Board will revisit this tonight in New Business.

#### Financial aspects of FEMA Grant

Harold Harris and Gary Jacobs, Melissa Hart

Applying for a FEMA Grant from TX – putting in parking lot lights, ballistic window treatment, and other security assessment items from last year. If we do get a grant for \$150K – can only apply for what was written up during the assessment by the Federation in Dallas. Grant requires CKA to pay vendor first and then get reimbursed by Federal Government. Some members have volunteered to put up the money in advance at no interest so there is not a cash flow issue. Can the committee go to members to borrow the money from Congregants to be paid back without interest? Becky believes only items the Board agrees on being done should be included. There are 3 things: lights in parking lot, ballistic covering on glass, and a fence around the property (such as wrought iron). The committee doesn't think we can do all three this year within funding provided by the grant anyway. So the fence can be put off. Fence will probably only go between CKA and apartments. The Federation also provides small grants.

## Adult Hebrew class Mollie Marks

Mollie would like to start Adult Hebrew Class in February. She asked if it could be offered via Zoom. Bob said he thinks it would be ok, he will check the calendar. CKA only charges nonmembers for education. We charge \$125 for Intro to Judaism (non-members) so probably the same for this course.

- 1. Kenny's time as HOA president is coming to an end. He will have more time to deal with open issues such as: a sign by the bowl with stones letting visitors know that the stones are periodically returned to the bowl when maintenance is done. Also, something will go out with newsletter.
- 2. Kenny will talk to Kacy about any of her issues with groundskeeping, etc.
- 3. There is an unauthorized bench sitting in the middle of the cemetery it's the shape of a Chai. From a vendor. Cemetery Committee and then Board will have to decide whether to remove it. He prefers standard benches already being used and not placed at a headstone.
- 4. Looks like a couple more spaces will be purchased soon. Kenny will meet with perspective purchasers to tour the sites available.

#### **New Business**

- 1. Steve stated that he is available whenever we need him. Feel free to contact him with concerns. He appreciates a heads up before guests bring up a discussion item.
- 2. The Board discussed fees for groups using CKA building. Currently those that aren't open to other members joining are charged \$50/month (For Musar meeting weekly, this is \$10-\$15 a week depending on the month.) Currently this is the only outside group that isn't open to other members. Debra suggested that we charge all groups a set amount each month. Don feels this

penalizes groups and we want to promote/encourage members to come to the building. We could drop the fees all together. Or we could ask for voluntary donations. Bob motioned to keep the fees as is. The Board voted to keep the fees as is. If other groups want to make a voluntary donation of \$10/hour for the building use, that is an option.

3. Since service attendance is increasing, is \$40 donation for the Oneg still ok? Can't change fees this year but for future fiscal years we should re-visit. Kenny suggests putting fees on the Agenda at the Annual Meeting to let members know what the fees are and publish them. Bob will bring the fee list to the next meeting for the Board to discuss.
