He has reviewed people not coming back to the board next fiscal year (Helena, Karen, Linda, Casey, Don, Greg). Brandi agreed to take the Executive VP role. Howie will take VP Fundraising. Rabbi's Report Rabbi Dennis

- 1. We are getting an intern from Hebrew Union College. She is a fourth-year student, Gretchen Johnson, from DFW. Her housing is set, and she receives a stipend. CKA just needs to help feed and entertain her. It is an opportunity for us to interact with her. She will be here all summer. Building Don Dossey

- 1. The Fire Department required some repairs. Don is working through the items. He replaced one exit sign so far and there are some bulbs in the sanctuary which require replacing. He put out yahrzeit plaques and leaves. He replaced the lock set on the portable building, so we now have a key. We now have a new mailbox post and mailbox. We had a tree removed with the help of Gary Jacobs for possible interference with electricity and damage to building.
- 2. Presently the air conditioning in kitchen is not working but opening the rollup door is keeping it cool. Steve suggested replacing the 3 units on larger flat roof section with 2 and maybe one being larger. The unit outside the kitchen, in Onegie Hall, is also down. It's not cooling. Don says the kitchen may be ok, but the Onegie Hall unit does need replacement.
- 3. Currently looks like the security project will be going forward. Steve will follow up with Security Committee. Waiting on funds from FEMA so hopefully it doesn't get hung up.

Steve will come back with another proposal and call an interim Board meeting in preparation to present at the annual meeting.
